# U.S. CONFERENCE OF MAYORS/ WAL-MART FOUNDATION GREEN JOBS TRAINING INITIATIVE BEST PRACTICE GRANTS

Submissions Due APRIL 17, 2009





The United States Conference of Mayors (USCM) is the official, nonpartisan organization representing cities with populations of 30,000 or more, and thus the interests of more than 1,100 cities at the national level. Its issue level is broad and its organizational and policy development structure facilitates a multi-disciplinary approach to issue advocacy, best practices and technical assistance.

On January 17, 2009 the Conference of Mayors announced a new partnership with the Wal-Mart Foundation establishing a \$5 million grant program to support green jobs training. Under the grant, six grants will be awarded in the spring of 2009 to train people for green jobs. These grants will be awarded under the auspices of The U.S. Conference of Mayors Workforce Development Council, an affiliate organization of the Conference of Mayors.

For over 25 years the United States Conference of Mayors has demonstrated its commitment to the development of a strong local workforce through its active sponsorship of the *Workforce Development Council* (WDC). The Conference of Mayors Workforce Development Council provides a forum for mayors and their employment and training administrators to examine all workforce development issues and to strengthen the ability of cities to meet the needs of their citizens; particularly economically disadvantaged individuals, those with serious skill deficiencies, dislocated workers, and others with special barriers to employment, including youth.

With an impressive record of accomplishments, the WDC remains the most important voice in the nation for the myriad of workforce issues faced by cities, and a dynamic vehicle to help mayors and their staff members address local economic, education, training and job challenges in an increasingly complex world, particularly the transition from blue collar to green collar jobs.

In June 2007, The U.S. Conference of Mayors Workforce Development Council created a *Green Jobs Task Force*. The mission of the task force is to examine mayoral initiatives for accelerating the green economy in order to develop a clearer understanding of what types of policies and programs could ensure that green collar jobs are made available to workers with limited initial education and skills; and to ensure that these jobs are stable, living wage jobs that provide benefits to workers and their families.

#### **Green Jobs Training Initiative Best Practice Grants**

Energy, climate protection, and green jobs have been top priorities in the Conference's work with mayors. This year, through a collaboration with the Wal-Mart Foundation, the USCM Workforce Development Council will identify six "Best Practice" city sites with potential for expansion, evaluation and replication of green jobs training programs conducted by 501(c)(3) organizations for the award of six Green Jobs Training Program Grants.

The Best Practice cities would embody mayoral leadership in green jobs and innovative strategies in communities that excel in green jobs efforts. The grant awards would support the work of mayors in partnership with 501(c)(3) organizations in their cities to establish comprehensive green jobs training initiatives.

Award winners will be notified of their grant award on May 11, 2009 to support the expansion opportunities of these best practice programs. Only cities that are members of The U.S. Conference of Mayors with representation on the Workforce Development Council, in partnership with a 501(c)(3) organization, are eligible to apply.

This is phase-one of a two-phase grant. In year two of the Green Jobs Training Initiative, USCM will develop a grant awards program to support pilot green jobs training program development in three grantee cities. Unlike phase-one, all member mayor cities can apply for the second round of awards. USCM will award pilot program grants to three cities to support new green jobs training programs conducted by 501(c)(3) organizations. Again, grant awards would focus on a strong partnership between the mayor and 501(c)(3) organizations in his/her city to implement a comprehensive green jobs training initiative.

#### **Grant Size and Determination**

The Green Jobs Training Best Practice Grants will be presented in three population categories – small, medium and large -- one award for cities of fewer than 200,000 people, four awards for cities of 200,000 to one million inhabitants, and one award for a city size with a million or more in population.

One - \$700,000 grant award to a large-size city Four - \$550,000 grant awards to medium-size cities One - \$372,500 grant award to a small-size city

## ONLY MEMBER MAYOR CITIES WITH WORKFORCE DEVELOPMENT COUNCIL MEMBERSHIP, IN PARTNERSHIP WITH A 501(c)(3) ORGANIZATION, ARE ELIGBLE TO APPLY.\*

## One Application Per City

\*The applicant must also be a public charity as described in section 509(a)(1) or 509(a)(2) of the Internal Revenue code. The non-profit entity will be the grant award recipient.

### **Important Application Information**

Only 501(c)(3) organizations in partnership with member Mayor Cities who hold a membership on the Workforce Development Council (WDC) can apply. The applicant must also be a public charity as described in section 509(a)(1) or 509(a)(2) of the Internal Revenue code. One application per city.

Eligibility:	To be eligible, non-profit organizations must submit an application in conjunction with a member Mayor of The United States Conference of Mayors who has a representative on The U.S. Conference of Mayors' Workforce Development Council (WDC). If you are unsure of membership status of either the mayor or the WDC member, please contact The U.S. Conference of Mayors.

Award-Winner Notification:	May 11, 2009	
Selection Announcement:	Annual Conference of Mayors - June 2009	
How to Apply:	Each award consists of five parts: a completed entry form, statement from the mayor, executive summary, budget proposal, up to ten pages in response to the proposal content questions, and supporting documentation.	
Statement from the Mayor:	The proposal should include a brief statement from the mayor indicating how he or she selected the non-profit organization for submission and how that entity will impact workforce development in the city.	
Executive Summary:	The executive summary should be no more than one-page (may be single-spaced) and should describe the key elements of the partnership between the non-profit organization and the city, provide measurable results on how the partnership has enhanced green jobs training in the community, and address the judging criteria relevant to the entry. Graphs and charts summarizing data are recommended.	

## **Important Application Information**

Supporting Documentation:	Supporting documentation must include a copy of the non-profit organization's Internal Revenue determination letter regarding 501(c)(3) status, as well as a copy of the non-profit organization's last financial statement to determine capacity. Other supporting documentation may include educational/promotional materials, brochures, statistics, news clippings, citations, etc.*	
Submissions:	Applications should be completed and saved as a PDF or Word Document in one attached document no longer than 15-pages total. 	<ul> <li>All question responses must be single-spaced in 12-point, Times New Roman font and should address each of the selection criteria questions or statements accordingly.</li> <li>Proposal must include the one-page cover sheet with relevant contact information for the mayor, WDC member and non-profit organization.</li> <li>Submit proposal components as one Microsoft Word (1997-2003) or PDF document that includes the attached coversheet, statement from the mayor, executive summary, budget proposal, proposal content question responses, and mandatory supporting documents. Applications are not to exceed 15 pages, <i>including</i> the cover sheet and mandatory supporting documents. - 4. Outline the job placement rates resulting from your green jobs training program, including number of participants placed in jobs, whether adult or youth, wages, population served, and other outcomes. Also, please describe any opportunities for on-the-job training.
- 5. Describe the types of jobs, whether entry-level position, mid-level or professional, and what, if any, career pathways were developed in your green jobs training program.
- 6. Describe the approach you will take to expand the program with this grant. Also, include information on how this program will be evaluated.
- 7. How will you design the expansion of this program so that it is easily replicated?
